ORDER

In partial modification of extant Standard Operating Procedures for persons travelling to Assam, the following revised instructions are issued in respect of exemptions from institutional quarantine, for compliance by all concerned:-

- 1. Any woman who has travelled alone to Assam by train or flight need not undergo institutional quarantine, provided she is asymptomatic. However, she shall undergo 14 days home quarantine after compliance with health protocols such as collection of swab samples for COVID-19 test, hand stamping, conversion of residence into a containment zone, etc.
- 2. Any senior citizen (60 years of age and above) who has travelled to Assam by air need not undergo institutional quarantine, provided he/ she is asymptomatic. However, he/she shall undergo 14 days home quarantine after compliance with health protocols such as collection of swab samples for COVID-19 test, hand stamping, conversion of residence into a containment zone, etc.

It may be noted that the exemption from institutional quarantine in case of senior citizens is not applicable for travel by bus or train.

Both the above exemptions from institutional quarantine will not be applicable if the bus/ train/ flight in which the person has travelled has been found to have a high incidence of COVID-19 positive cases or has been contaminated in some way.
