

**Minutes of the 48<sup>th</sup> SEC Meeting held on March 29, 2023 in the Conference Hall of Chief Secretary, Assam, Janata Bhawan, Dispur.**

At the outset of the meeting the Chairperson welcomed the members present.

After deliberation on the agenda placed before the State Executive Committee (SEC), following resolutions were made.

**48. 1: Confirmation of minutes of the 47<sup>th</sup> Meeting of SEC**

**Resolution:** The State Executive Committee confirmed the minutes of the 47<sup>th</sup> meeting of the committee held on February 10, 2023.

**48. 3: Snapshot of resources & expenditure for 2022-23 under SDRF/ NDRF**

**Resolution:** The SEC took note of the status of resource availability and expenditure for 2022-23 under SDRF / NDRF as placed in the agenda.

SEC also directed the Finance Department to examine if pending liabilities under SDRF / NDRF for the year 2022-23 can be cleared subject to budget availability.

**48. 4: Status of Administrative Approval to SDRF proposals approved in the 47<sup>th</sup> meeting of SEC**

**Resolution:** The SEC took note of the status of issuance of Administrative Approval to SDRF proposals of various departments which were approved in the 47<sup>th</sup> SEC meeting held on February 10, 2023 as placed in the agenda.

**48.5: Appeal made by the PWD Roads department for approval of SDRF proposals of PWRD as per SOR instead of extant norms of SDRF**

**Resolution:** The SEC observed that the norms of SDRF/NDRF issued vide MHA letter No. 33-03/2020-NDM-I, Dt. 10.10.2022 should be followed.

**48.6: Approval to SDRF proposals of PWD Roads department**

**Resolution:** The SEC approved 48 proposals of PWD Roads

department amounting to Rs. 179.0141 lakh admissible under present SDRF norms list of which is placed at **Annexure-II**. SEC also directed ASDMA to return the non-admissible proposals to the PWD Roads department.

**48.7: Approval to financial assistance for weavers under SDRF for Handloom & Textile Department**

**Resolution:** The SEC directed to place the proposals under this head in the next meeting of SEC after collecting the pending proposals from all the districts.

**48.8: Approval of SDRF proposal of P & RD department for protection and restoration works executed under Section 50 of DM Act.**

**Resolution:** The SEC directed ASDMA to return the proposals of P & RD department as the same are not admissible under SDRF norms.

The State Executive Committee directed ASDMA to place the rest of the agenda items in the next meeting of SEC for consideration as the same could not be taken up for discussion due to paucity of time.
